Supported the operation and improvements to the Mayan Children's Village which housed 16 children (11 boys and 5 girls) who would otherwise be unable to attend upper grade school through high school. The Village provides a home including room, board and supervision that involves the children mentally, spiritually, physically and thru service. It is effectively an orphanage for a few. It is located in El Ideal, Quintana Roo, Mexico.

4b (Code:) (Expenses \$ 67,178 including grants of \$) (Revenue \$ 0)

Supported the operation of and improvements to the Merida Student Houses which house students who would otherwise be unable to attend higher education. A new Women's House opened for fall 2021, starting with 4 young women. The Men's House serves 11 young men. The men and women attend colleges and seminaries, studying engineering, theology, tourism, business, education and other degree curriculums. Merida Student House provides a home including room, board and supervision. In 2021, 3 scholarships were provided for school fees and expenses.

Provided emergency assistance needed due to pandemic and flooding, specifically 400 food boxes for villagers and assistance to 4 pastors.
